PREPARATION

- Always open and use adhesive products over a protected work surface.
- 2. Ensure the surfaces to which Bostik PVA Glue is to be applied are clean and dry.

APPLICATION

- 3. Twist the blue part of the nozzle anti-clockwise.
- 4. Squeeze the bottle gently and apply the glue to one or both surfaces.

- For non-porous surfaces, allow the glue to become tacky to the touch before bringing the surfaces together.
- 6. After use wipe the nozzle and turn the nozzle clockwise to stop glue drying out.

CLEANING

- Any excess glue can be removed by using a damp clot
- 8. Can be washed out of clothes using warm soapy water, ideally before glue is dry.
