APPLICATION

- Surface should be free of grease, oil, dirt or other contaminants.
- Remove protective cap.
- Turn base clockwise until glue protrudes (only expose a little glue for use).
- Apply glue with firm even strokes to one surface.
- Allow 60 seconds for the glue to dry before pressing the two surfaces together.
- To remove or reposition, start and one corner and gently pull away.
- When finished, turn base anti-clockwise to retract
- Recap when not in use to prevent glue from drying out.

CLEAN-UP

Glue can be removed with normal washing.

STORAGE AND SHELF LIFE

Store in a cool, dry conditions between 5°C to 35°C, out of direct sunlight. Shelf life is 2 years from the date of manufacture when stored as directed.
