APPLICATION

Remove protective cap. Turn base clockwise until glue protrudes (only expose a little glue for use).

For best results apply twice before sticking substrates together.

When finished, turn base anti-clockwise to retract glue. Recap when not in use.

STORAGE & SHELF LIFE

Store in a cool, dry conditions between 5°C to 30°C out of direct sunlight. Shelf life is 2 years from the date of manufacture when stored as directed.

If needed, glue can be removed from fabrics and clothes by washing at 40°C.
